### **POSITION SUMMARY**

Cleans dining rooms, living rooms, hallways, bathrooms, resident rooms, kitchens, stairwells, and offices at Marygrove by performing the following duties.

This position requires training in the Archdiocesan program Protecting God's Children.

### **OVERVIEW & RESPONSIBILITIES**

- All floor care (i.e. dust mop, wet mop, sweep, scrub, wax, and polish).
- Cleans rugs, carpets, and draperies.
- Strips, waxes and buffs floors.
- Cleans furniture (i.e. upholstered furniture, desktops, and table tops).
- Cleans lobbies, lounges, rest rooms, hallways, and stairways.
- Dusts furniture, and high and low areas of walls. Washes walls, ceiling, and woodwork. Washes windows, door panels, and sills.
- Empties wastebaskets and empties and cleans ashtrays.
- Transports trash and waste to disposal area.
- Replenishes bathroom supplies. Replace light bulbs.

- Observes and reports any and all safety and maintenance requirements.
- Performs related duties as assigned by supervisor.

## **KNOWLEDGE & EXPERIENCE REQUIREMENTS**

 High school diploma or general education degree (GED); or one to three months of related experience and/or training; or equivalent combination of education and experience.

### PHYSICAL DEMANDS

While performing the duties of this job, the employee is regularly required to stand; walk; use hands to handle, or feel; reach with hands and arms; and stoop, kneel, crouch, or crawl. The employee is occasionally exposed to outside weather conditions. The noise level in the work environment is usually moderate.
